

# THE SAUCE GAMES at RedTail

Official Rules & Regulations (“Rules”)

Sunday, July 3, 2022

PLEASE CAREFULLY READ THESE RULES BEFORE PARTICIPATING IN THE SAUCE GAMES (“CHALLENGE”) AS THESE RULES AFFECT YOUR LEGAL RIGHTS AND OBLIGATIONS.

- Subject to all applicable federal, state and local laws. Void where prohibited.
- **IMPORTANT NOTICE: PARTICIPATION IN THE CHALLENGE AND PRIZE ELIGIBILITY ARE SUBJECT TO REDTAIL MANAGEMENT APPROVAL, PARTICIPANT COMPLETING AND SIGNING A WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT PRIOR TO PARTICIPATION IN THE CHALLENGE.**
- The Challenge is operated by RedTail Management. Invited Participants have the opportunity to win potential prizes as provided in these Rules. ## **QUALIFICATION**

- The Challenge will take place at Resorts World Las Vegas, inside of RedTail, at 8:00 p.m. (PST) on Sunday, July 3, 2022.
- Registration for the Challenge will take place from 7:00 p.m. to 8:00 p.m. (PST) on Sunday, July 3, 2022 at the RedTail Host Stand.
- Position assignments will be randomly assigned. RedTail Management shall have the sole and absolute discretion to determine final position assignments.
- Failure to be present at the start of the Challenge may be cause for disqualification.

## **CHALLENGE RULES**

Participants must eat as many RedTail Challenge wings as possible in five (5) minutes. Participants will be timed by RedTail Management. Participants must follow the following rules during the Challenge:

- 1) Remove all RedTail Challenge wing meat from the bone, with the Participant's mouth only, subject to RedTail Management's discretion.
- 2) Anyone who vomits or regurgitates during the course of the Challenge is automatically disqualified.
- 3) Participants are allowed two (2) bottles of water.
- 4) Other than the RedTail Challenge wings, during the Challenge, Participants cannot use any other food, condiment, or sauce, including, but not limited to: celery, bleu cheese or ranch dressing.
